

## WORLD AT RISK:

RISK SCENARIOS AND/IN CULTURAL STUDIES





"We live in the age of unintended consequences." This is how sociologist Ulrich Beck defines the emergence of the "world risk society," a type of society characterized by processes of modernization and globalization that have produced risks – technological, environmental, financial risks, for instance – that are no longer fully calculable and have therefore changed societies worldwide. The lecture series "World at Risk: Risk Scenarios and/in Cultural Studies" starts out from this insight but shifts its focus on the meaning of risk for various cultural practices.

The lectures acknowledge that risk scenarios communicated in language, in literary texts (both fictional and non-fictional), in music, body art performance, in film, and in the martial arts play a central role in various risk discourses. Due to their often wide distribution and easy accessibility they have a much stronger impact than, for instance, scientific texts in terms of making risks concrete, suggesting solutions how to deal with them, but also in terms of addressing the spectacle, shock, and threat linked to them. Approaching risk from various disciplines in the field of cultural studies, the single lectures investigate various risk scenarios to show how cultures shape risks and are in turn shaped by them.
